#### 4.1 Superintendent Updates to the Board

Mr. Sutton stated, "Good evening everyone, Last week was Teacher Appreciation week. We're so thankful for our teachers dedicated to helping prepare children for the future. They do everything from teaching core subjects to providing an extra snack when someone needs it, giving hugs when a student needs to feel some support, meeting and partnering with families to help their student succeed, collaborating with other teachers, going to professional development to make sure they're using the best practices for working with their students, and so much more. #### 7.1 Custodial Supplies

Dr. Carrington presented to the board for approval the information on the purchase of custodial supplies for Warren County Schools. It was stated, "Restart Applications. It was stated, "In an effort to improve the cleaning and maintenance of our facilities, we have completed an assessment of the necessary equipment and supplies needed in each building. Additional cleaning equipment and materials are needed to support these needs. This list includes items such as buffers, scrubbers, water extraction machines and other items to properly clean and maintain floors throughout the schools. Capital funding is available for this purchase."

**Motion:** After further discussion, a motion was made by Ms. Sims and seconded by Ms. Talley Brame to approve the purchase of the custodial supplies per purchasing contract approval by attorney and superintendent.

Result: Motion passed, 4-0

# 7.2 EC Service Amendment Agreement

Mrs. Blythem De Sare, Director of Exceptional Children, presented to the board for approval, an amendment agreement for exceptional children speech services. It was stated, "Additional funds of \$12,500 is needed to cover speech services for the 2023-2024 School year; increasing contract amount."

**Motion:** After further discussion, a motion was made by Ms. Talley Brame and seconded by Ms. Long to approve the EC service amendment agreement for speech services as presented.

**Result:** Motion passed, 4-0

# 7.3 2024-2025 Elementary and Secondary Instructional Calendars

Mrs. Debra Clayton, Director of Testing and Accountability, provided a final overview of drafts of the 2025- 2026 Elementary and Secondary Instructional calendars. The proposed 2025-2026 instructional calendars contain at least 1025 instructional hours. They also meet all other requirements of the state calendar law.

**Motion:** After further discussion, a motion was made by Ms. Talley Brame and seconded by Ms. Long to approve the 2024-2025 Elementary and Secondary Instructional calendars as presented.

**Result:** Motion passed, 3-1 (Sims voting no)

## 7.4 2024-2025 Proposed Superintendent's Budget

Mr. Jeremy Teetor, School Operations Specialists, presented to the board for approval the Superintendent's Proposed 2024-2025 Budget. The proposed budget is estimated at nearly \$65 million. The proposed budget seeks approximately \$5.3 million from Warren County Commissioners for operating costs and approximately \$500,000 in capital funding support to address facility needs. This funding would help to cover the cost of some major repairs and deep cleaning of our schools and make significant improvements to physical education and athletic facilities.

**Motion:** After further discussion, a motion was made by Ms. Sims and seconded by Ms. Talley Brame to approve the 2024-2025 Proposed Superintendents' budget as presented.

**Result:** Motion passed, 4-0

# 7.5 Fall Policy 2023 Updates (First Reading)

Dr. Whitaker presented to the Fall Policy 2023 Updates to the Board for first reading approval. It was stated, "The Fall 2023 Policy Custom Updates from the North Carolina School Board Association were reviewed by the Warren County Schools Board of Education Policy Committee and Executive Cabinet and are being recommended for approval on first reading."

**Motion:** After further discussion, a motion was made by Ms. Talley Brame and seconded by Ms. Long to approve the first reading of the Fall Policy 2023 Updates as presented.

Dr. Carrington presented to the Board for approval information on the HVAC unit at WCHS. It was stated, "This is to remove the existing condensing unit from the roof and install new 50 ton Trane unit on roof."

**Motion:** A motion was made by Ms. Long and seconded by Ms. Talley Brame to approve the purchase of the new HVAC unit at WCHS pending approval of the purchasing contract by the attorney and the superintendent.
