Summer Testing Plan **DRAFT**

SY 2024-2025

The North Carolina Department of Public Instruction will allow districts to offer a summer school program for testing students who were not proficient on the End of Course (EOC) or End of Grade (EOG). The summer testing scores will not be included in growth for school accountability or for educator effectiveness; however, the higher score will be included in proficiency for school accountability purposes. NCDPI does not allow using the summer test score to change final course grades for any student. The 2024-2025 accountability year ends Monday, July 7, 2025; therefore, all scores must be uploaded to NCDPI by July 7, 2025.

• Purpose of the program

- Through remediation, students are offered an additional learning opportunity outside of the regular academic calendar.
- Schools and district proficiency rate should increase.

• Who is eligible to attend

- Students in grades 4-8 Reading, grades 3-8 Math must meet at least one of the following criteria to be eligible to participate in summer remediation and testing for Reading or Math.
 - EOG scale score must be within three (3) points of proficiency
 - EVAAS achievement level prediction is at least 65% for level 3
 - Teacher/principal recommendation
- Students in EOC (courses): English II, NC Math I and NC Math III must meet at least one of the following criteria:
 - EOC scale score must be within three (3) points of proficiency
 - EVAAS achievement level prediction is at least 65% for level 3
 - Teacher/principal recommendation

• Logistics

- Student participation is voluntary.
- Students have to attend summer remediation on the designated day(s) in order to be able to participate in the summer testing.
- There will not be any makeup days for testing
- Parents or guardians make the final decision regarding whether or not their child attends summer testing

- Parents will be notified by their child’s school principal if summer testing is an option for their child
- Students are held harmless if they do not attend
- the school day will begin at 8:00 am for all schools with a 2:00 pm early release in order to provide the 4 hours required to test EOGs and EOCs.
- Remediation and testing will occur at the school in which the student is enrolled
- Buses will run.
- Breakfast and lunch will be provided to students at no cost.

• Security of Test Materials

- Testing will be online
 - Test administrators are not allowed to leave testing room
 - Students must pause testing devices during breaks
- The School Test Coordinators (STC) will check out materials from the district testing office using district forms and secure the materials in their respective school as indicated in their testing plans which they will submit to the District Director of Testing and Accountability.
- The test administrators at each school will check out their testing packet from their STC and return the packet to their STC once testing is over.
