## 7.2 2025-2026 School Calendar Discussion

Mrs. Clayton and Maya Weinstein, Board Attorney, discussed the possibility of transitioning from two academic calendars to one. Attorney Weinstein stated,

- Calendar law does not apply to restart schools or early colleges
- Narrow "good cause" exception for waiver
  - Statute specifically defines "good cause" closed 8 days/year during any four of the last 10 years because of severe weather, energy shortages, power failures, or other emergency situations
  - The "good cause" exception only gives DPI authority to waive the requirement and set the opening date no earlier than the Monday closest to August 19

• DPI is not given authority by the legislature to do anything beyond this This was for discussion only.

Dr. Whitaker presented information regarding the potential move of the Board of Education meeting location from WCMS to the Warren County Schools Auxiliary Building. This was for discussion only.
