1.0 Opening of Meeting

The Warren County Board of Education met for their Regular Board Meeting on Tuesday, May 28, 2024 at 6:09 p.m. at Warren County Middle School located at 118 Campus Drive, Warrenton, North Carolina.

1.1 Meeting Call to Order

Ms. Lehman announced the establishment of a quorum and called the May 28, 2024 Work Session/Business Meeting to order.

2.0 Board Chair Announcements

2.1 Board Chair's Comments

Board Chair Lehman stated, "Good evening. We just recognized all retirees' today right before this meeting started; but I would also like to recognize all graduates, teachers, and students for all their hard work this school year. I wish everyone a wonderful summer season."

3.0 Superintendent's Updates

3.1 Superintendent Updates to the Board

Mr. Sutton stated, "Good evening everyone, "Summer Learning Programs Registration is still open for the school district's summer learning programs! All of our camps are at no cost to families. Breakfast, lunch, and transportation

are provided. Space is limited so please register your student now. We're offering programs for all school-age groups, with focuses on reading, math, arts, career and technical education, and transportation. High school students could even earn *money* just by actively participating in certain camps. We're holding an online Virtual Family Meeting about our summer learning programs tomorrow night, Wednesday, May 29 from 5:30 - 6:30 p.m. We have the link to join that virtual family meeting and information about all of our summer learning opportunities posted on each school's website and the district website, www.warrenk12nc.org.

Once again, I want to congratulate the 129 new graduates of Warren County Schools. Saturday, we celebrated 107 students for their graduation from Warren County High School. Together, the Warren County High School class of 2024 earned nearly one-and-a-half million dollars in scholarships. (lead applause) We also have several students joining the military and others going straight into the workforce. Similarly, the week before we celebrated the 22 graduates of Warren Early College High School. All 22 of them graduated with their high school diploma and an associate's degree from Vance Granville Community College. And all 22 of them have been accepted to 4-year colleges or universities. We are so proud of every one of these young people and their accomplishments so far. I say so far because we are just as excited to see what they'll accomplish in the future. Congratulations to our Class of 2024!

While the high schools have wrapped up for the year, our middle and elementary schools are still going. We've still got EOGs, so there's no skating through these last couple of weeks. We want to make sure our K-8th graders finish strong. We also want to mention their upcoming promotion ceremonies.

- Mariam Boyd and Vaughan Elementary both have their promotion ceremonies on the last day of school Friday, June 7th, both at 9 a.m...
- Warren County Middle School is holding its 8th-grade promotion ceremony that same evening Friday, June 7th at 6 p.m.

Now is the time to register your 3, 4, or 5-year-old for kindergarten or pre-k. All you have to do is go to the elementary school closest to your home and they'll help you enroll your child. For kindergarten, your child must be 5 years old before August 31. For pre-k, they have to be 4 by August 31. We have a list of the documents you'll need on our website. 7.0 **Information Items**

7.1 Teacher and School Leader Incentive Grant - Reimagining Teaching Talent

Mrs. Raushawna Price, Eyrie Success provided an overview to the board on the Teacher and School Leader Incentive (TSL) Grant. It was stated, "The Innovation Project (TIP), of which we are a member, was awarded over twenty-one million dollars through the Teacher and School Leader Incentive Program (TSL) Grant administered by the U.S. Department of Education. TSL funding will support TIP's Reimagining Teaching Talent (RTT) program, a partnership which provides 79 schools across eight school districts the opportunity to work together in a networked improvement community (NIC). The NIC will focus on promoting equity in student access to educational resources and opportunities, supporting a diverse educator workforce, and ensuring educators' professional growth to strengthen student learning. RTT will focus on the greatest school-related influencers on student achievement: the recruitment, development, and retention of teachers, teacher leaders, and principals. Educators will engage in a widerange of wrap-around supports, including leadership academies, professional learning communities, and individual and peer coaching. Districts will also work to establish district-university partnerships with Historically Black Colleges and Universities (HBCUs) to provide a direct pipeline of educators, create year-long, multi-stakeholder, and equity-driven recruitment and retention systems, and provide support to new educators who are trying to pass the Praxis Tests. TIP will partner with and support eight school districts in North Carolina: Asheboro City Schools, Edgecombe County Schools, Elizabeth City-Pasquotank Public Schools, Lexington City Schools, Mount Airy City Schools, Scotland County Schools, Vance County Schools, and Warren County Schools." Board members were also provided additional handouts.

8.0 **Action Items**

Relay/Warren County Partnership

Mr. Sutton along with two NCILEA department leaders from the NC Department of Public Instruction, and Dr. Clemons presented to the board for approval information on the Relay/Warren County Partnership. In March, 2023, State Superintendent, Catherine Truitt, recommended, and the State Board of Education approved the use of additional ESSER funds to expand the support given to schools with a low performing designation. A review of those schools who have persisted with this designation since 2015 revealed 22 districts that could possibly benefit from expanded DPI services. Warren County Schools was one of the 22 districts that qualified for these services. In April, DPI

contacted Superintendent Sutton and offered these services which we accepted and the partnership with Relay began. Over the past school year, Relay provided 12 days of coaching in schools that involved classroom observations, planning supports for teachers and/or grade levels/departments, and practicing of instructional leadership skills. They also provided 8 hours of virtual coaching per month (8, 1 hour Zoom meetings or 11, 45 minute Zoom meetings). Meetings were with the Superintendent, district leaders and school leaders and focused on development of instructional leadership skills. School leaders in Warren County Schools and around the state have benefited tremendously from the Relay partnership. At this time, state funding for these services has ended due to the expiration of ESSER funds. Warren County Schools and Relay are working to create a plan to continue supporting the district and the progress that has been made. Staff is requesting approval of the proposal to continue services with Relay.

Motion: Following a discussion, a motion was made by Byrd and seconded by Ms. Long to approve the Relay/Warren County Partnership purchase contingent on reviewing and approval of service contract by superintendent and board attorney.

8.2 2024-2026 Local Application for Career and Technical Education

Mr. Derrick Fogg, Director of CTE presented to the board for approval the 2024-2026 local application for Career and Technical Education.

Motion: Following a discussion, a motion was made by Ms. Long and seconded by Ms. Byrd to approve the 2024-2026 Local Application for CTE (Career and Technical Education).

8.3 Elevate K-12 Proposal

Mr. Sutton and Dr. Whitaker presented to the board for approval the Elevate K-12 proposal. It was stated, "In an effort to address teaching shortages and staff vacancies, staff is proposing a partnership with Elevate K-12. Several districts around the state are turning to Elevate K-12 to provide remarkable teaching from a certified, experienced educator who is committed to student success. Elevate provides live online teaching from licensed North Carolina teachers. Unlike remote learning, students participate in LIVE classes together, in our classrooms, on our bell schedule. Partner districts provide on-the-ground support via Classroom Coaches, often paraprofessionals, long-term subs, or staff members. Warren County Schools is seeking to pilot this program at Warren County High School for the 2024-2025 School year. Staff is seeking approval of the Elevate K-12 Proposal, subject to a properly executed service contract approved by the board attorney and superintendent. It was stated, "The Academic Services department is seeking board approval to renew the iReady Math and Reading program for the 2024-2025 school year. All curriculum and instructional resources are designed for K-8 students and aligned to the ELA and Math North Carolina Standard Course of Study. The iReady products and services include the following:

- i-Ready (diagnostic assessments for reading and math)
- i-Ready Classroom
- Teacher Toolbox
- Think Up! Teacher Manuals and Student Workbooks
- Ready Teacher Manuals and Student Workbooks
- i-Ready Partners Services
- Professional Development

Motion: After further discussion a motion was made by Ms. Long and seconded by Ms. Byrd to approve the purchase of the iReady Reading & Math materials.

Result: Motion passed, 4-0

8.5 Summer Testing Schedule

Mrs. Debra Clayton, Director of Testing and Accountability presented to the board for approval a request to amended Summer Testing schedule. It was stated, "We are requesting to add the days of May 29th through May 31st for 10 English II students. 9 of the 10 students are within 3 pts of recommendation. If the students are allowed to retest and if all student are proficient then the proficiency rate could increase by at least 10 percent."

Motion: A motion was made by Ms. Long and seconded by Ms. Byrd to approve the amended Summer Testing Schedule by adding May 29th through May 31st for the 10 English II students.
